The following are clarification notes made to the plans or specification. The changes are outlined by item number, as well as plan sheet number or specification section.



General:

- ITEM 1. Refer to attached Sign-In Sheet for Pre-Proposal Conference.
- ITEM 2. Question: In page seven (7) of the Contractors Agreement, section 7 Insurance, Item 7.1 of the first paragraph it talks about "professional liability insurance". Shouldn't this read, "General Liability Insurance" in lieu of "professional liability insurance". Please advice.?

 Answer: Contract should read General Liability Insurance.
- ITEM 3. Question: What are the Technical Proposal criteria?

 Answer: Page 6 of the Specification Manual lists the Evaluation Criteria that will be used.
- ITEM 4. Question: On page 7, Section 29 of the Specs, it is mentioned that information will be evaluated on the Contractor's Information Statement Form, where can this form be located?

 Answer: No form will be provided. Proposers will be allowed to submit an AIA-A305 or similar form. Sample has been provided.
- ITEM 5. Question: Mechanical Schedule "VFD Schedule" does not indicate if the VFD's require a bypass. Do the VFD's require bypass?

Answer: Yes, the VFD's will require a bypass.

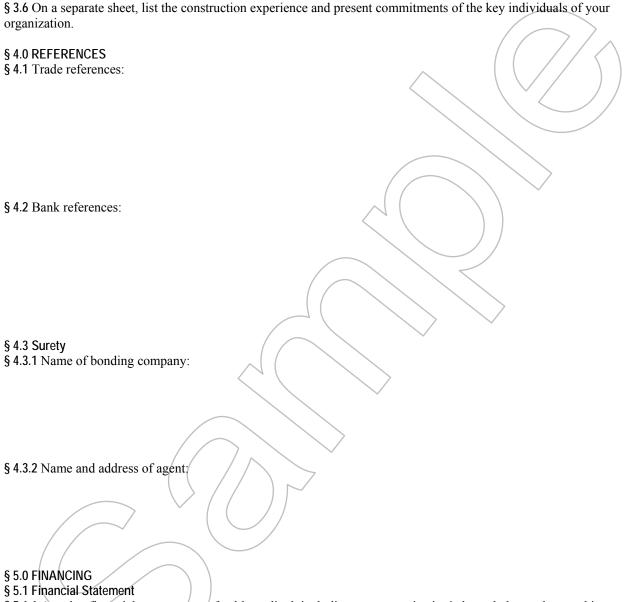
